# RESOLUTION OF THE GLOUCESTER COUNTY UTILITIES AUTHORITY OF THE COUNTY OF GLOUCESTER AUTHORIZING CHANGES TO THE PERSONNEL MANUAL MANAGEMENT AND OFFICE PERSONNEL MANUAL

WHEREAS, there exists a need to enact certain changes to the Gloucester County

Utilities Authority Personnel Manual Management and Office Personnel Manual as follows

(proposed changes are double underlined below):

### 6.2 NON-CONTRIBUTORY GROUP LIFE INSURANCE PROGRAM

Under this program, the GCUA, at the employee's expense, provides term life insurance to its employees for payment equal to 1½ times the annual salary of an active employee to his/her designated beneficiary upon his/her death. The State contributes the other portion for the employee to get another 1½ times the annual salary of an active employee to his/her designated beneficiary upon his/her death for a total of 3 times. If the employee drops out of this program after their first year of employment, he/she cannot reenter this program.

NOTE: This language replaces the previous language which was incorrect.

### 6.9 <u>RETIREMENT BENEFITS</u>

Any employee retiring who, at the time of retirement, has at least 25 years of credited service in the New Jersey PERS System or equivalent State Retirement System and 10 years of service with the GCUA, or who reaches age 62 with at least 7 years of service with the GCUA and 15 years credited service in the New Jersey PERS System or equivalent State Retirement System shall be eligible for retiree health benefits (as set forth below) paid for by the GCUA (with any employee contribution required pursuant to State law). These benefits shall be provided to the eligible employee and spouse of records at time of retirement only. If spouse of record at time of retirement should survive the retiree, only he or she shall continue to receive benefits under this Section.

NOTE: The highlighted line was mistakenly left out of the retyped Personnel Manual. This is the same language as existed before the May 14, 2014 revision.

### 6.11 WAIVER OF MEDICAL/PRESCRIPTION PLAN

Employee who chooses to "opt-out" of the GCUA medical/prescription program and receive coverage under a spouse's or civil union partner's medical/prescription plan or other alternative coverage plan shall receive \$1,500.00 annually for Employee Only coverage; and \$3,600.00 annually for waiving Family coverage.

No payment will be made where the alternative coverage is also under the State Health Benefits Plan (whether or not through the GCUA.)

Note – no payments for "partial" waivers are permitted (e.g., waiving family coverage but taking employee only coverage).

Employees who waive their medical/prescription coverage must provide proof of alternative coverage. Employees who lose their alternative coverage due to a COBRA qualifying event may re-enter the GCUA plan immediately without any qualification. other than the return of the pro-rated amount of the payment received by the employee.

NOTE: The double underlined portions of this section are to be removed. The GCUA no longer will make "Waiver Payments" to those not taking the offered insurance.
