WHEREAS, NJ West Deptford Project, LLC, a Delaware Limited Liability Company with an office located at 4507 North Front Street, Suite 302, Harrisburg, PA 17110 (hereinafter, "Developer") entered into a Developer's Easement Agreement dated May 22, 2018, a copy of which is attached hereto and made a part hereof; and

WHEREAS, pursuant to paragraph 9 of the Developer's Easement Agreement, assignment of the Developer's Easement Agreement requires the written consent of the GCUA; and

WHEREAS, NJ West Deptford Project, LLC has requested the GCUA to consent to the assignment of the afore-described Developer's Easement Agreement to GPT BTS Mantua Grove Owner, LLC in connection with its transfer of its property at 240 Mantua Grove Road, West Deptford Township, Gloucester County, New Jersey; and

WHEREAS, Developer has provided a proposed Assignment and Estoppel Agreement; and

WHEREAS, the GCUA Executive Director has referred same to general counsel and the GCUA's Engineer for review; and

WHEREAS, due to time constraints the Board of Commissioners wishes to authorize the Executive Director to authorize an assignment and execute a Developer's Easement Estoppel provided staff, legal and engineering review produce no objections; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Commissioners of the Gloucester County Utilities Authority on this 13th day of February 2019, that the Executive Director is hereby authorized to execute a consent of assignment of the afore-described Developer's Easement Agreement upon satisfactory review as set forth above, in a form acceptable to the Executive Director, staff, the GCUA Solicitor and Engineer.
