Notice is hereby given that sealed bids will be received by the Gloucester County Utilities Authority (GCUA) on **Thursday, January 4, 2018 at 10am**, prevailing time at the GCUA Administrative Office, located at 2 Paradise Road, West Deptford, New Jersey 08066, at which time and place bids will be opened and ready in public for:

**FOUR (4) 2018 OR NEWER FREIGHTLINER 108SD SINGLE AXLE DUMP TRUCK WITH STAINLESS STEEL DUMP BODY WITH SNOW PLOW AND TAILGATE SPREADER (OR APPROVED EQUAL)**

The project principally consists of furnishing and delivering FOUR (4) 2018 OR NEWER FREIGHTLINER 108SD SINGLE AXLE DUMP TRUCK WITH STAINLESS STEEL DUMP BODY WITH SNOW PLOW AND TAILGATE SPREADER (OR APPROVED EQUAL) to the GCUA.

Specifications and other bid information may be obtained at the GCUA Administrative Office, 2 Paradise Road, West Deptford, New Jersey 08066 on or after Wednesday, December 6, 2017, between the hours of 9:00 a.m. and 3:00 p.m., Monday through Friday, except legal holidays. **Email requests should be sent to lleads @ gcuanj.com. All bid requests by email only giving name of company, full address, phone and fax numbers, email, and contact person.**

Each proposal must be accompanied by a Certified Check, Cashier's Check, or Bid Bond for not less than 10 percent (10%) of the total amount bid, but not in excess of \$20,000, made payable to the Gloucester County Utilities Authority.

The bid must be accompanied by a Non-Collusion Affidavit. Public Disclosure, Chapter 33 of the Public Laws of 1977 provides that no corporation or partnership shall be awarded any State, County, Municipal or School District contract for the performance of any work or the furnishing of any materials or supplies, unless, prior to the receipt of the bid or accompanying the bid of said corporation or partnership there is submitted a statement. The statement shall set forth the names and addresses of all stockholders in the corporation or partnership who own 10% or more of its stock or any class, or of all individual partners in the partnership who own a 10% or greater interest. **FAILURE TO SUPPLY THIS INFORMATION WITH YOUR FORM OF PROPOSAL WILL BE CAUSE TO REJECT THE BID.** The GCUA reserves the right to reject any or all bids or to waive any informality in the proposal received and to accept the bid which in their judgment will best serve the interests of the GCUA. Bidders are required to comply with the requirements of N.J.S.A.10:5-31 et seq. and N.J.A.C. 17:27 laws against discrimination because of race, religion, sex, color, etc.
