WHEREAS, Enright's Tree Service Limited Liability Company, 5 Miller Drive, Sewell, NJ 08080 are a licensed tree expert firm registered with the Board of Tree Experts and qualified

to provide tree removal, pruning, repairing, brush cutting and removal, stump grinding and removal, tree establishment, fertilization, cabling and bracing, lighting protection, consulting, diagnosis, and treatment of tree problems or diseases, tree management assessment and risk management; and

WHEREAS, Enright's has demonstrated an ability to provide such services on an emergency and non-emergency basis; and

WHERESAS, the Authority wishes to award a contract to Enright's for a 2-year period in accordance with N.J.S.A. 40A:11-5(gg); and

WHEREAS, the Executive Director has certified the availability of funds for such contract.

WHEREAS, the GCUA Engineer's June 24, 2019, written letter opinion certifying this as an emergency contract and recommended payment for the emergency repairs to Pioneer Pipe Contractors, Inc., in an amount not to exceed \$26,000.00, the Engineer's opinion is incorporated herein and made a part hereof this resolution.
