





**WHEREAS**, Clarifier No. 4 is an important component of the GCUA wastewater treatment operations and it is prudent to have the unit returned to operating status in an expedited fashion; and

**WHEREAS**, Clarifier No. 4 had a failure of 24” pipe, which separated at a point-of-connection, causing concern for the public health, safety and welfare; and

**WHEREAS**, the GCUA Engineer has certified in a May 25, 2017 letter to the GCUA that it was important that the wastewater feed valve to Clarifier No. 4 be repaired on an emergency basis and that an emergency contract needed to be awarded in accordance with the procedures for emergency contracts as promulgated and contained in *N.J.A.C. 5:34-6.1, et seq.* and *N.J.S.A. 40A:11-1, et seq.*; and

**WHEREAS**, the GCUA Engineer has certified and recommended the emergency purchase as a one-time event to address the immediate need to Clarifier No. 4; and

**WHEREAS**, the GCUA Engineer’s May 25, 2017, written letter opinion certifying this as an emergency purchase and recommended payment for the emergency repair of the wastewater feed valve to Clarifier No. 4 in the amount of \$3,050.00 is incorporated herein and made a part hereof this resolution.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Commissioners on this 14<sup>th</sup> day of June, 2017, that it hereby authorizes the payment of emergency repair of the wastewater feed valve to Clarifier No. 4, as outlined above and in the GCUA Engineer’s May 25, 2017,




