#### **USE OF GCUA VEHICLES Section 3.5.1**

GCUA vehicles assigned to employees are the responsibility of those employees and are to be used for GCUA business only. Employees may access GCUA vehicles through their department, or with advanced notice, employees may request the use of a vehicle through the "Loaner Vehicle" form, which is available from the Department Head/Designee.

All drivers of GCUA vehicles must possess a valid driver's license, and if applicable, a CDL. The GCUA reserves the right to check an employee's motor vehicle record at least annually after the date of hire.

The GCUA reserves the right to monitor the use of GCUA vehicles. The GCUA shall or may utilize GPS (global positioning systems) in any of its vehicles or equipment whether owned or leased.

GCUA vehicles are to be used for official business only, unless otherwise authorized by the Board of GCUA. Unauthorized personal use of vehicles is prohibited and shall because for disciplinary action and/or termination of employment. Only authorized employees are allowed to take home a GCUA vehicle. Permission to take home a county vehicle is determined by the Executive Director.

Employees who fail to follow established reporting procedures or are negligent in the use of GCUA property or vehicles may be subject to disciplinary action. Employees may be liable for damages incurred to or caused by GCUA equipment, property, and/or vehicles if such damage is the result of employee negligence. Any employee who is negligent in the operation of a GCUA vehicle may be subject to disciplinary action.

Driver related violations, parking and speeding tickets must be paid by the driver. Any incidents involving GCUA employees, property or vehicles which result in damages or injuries, no matter how minor, must be reported by the employee to his/her Supervisor immediately. Any damage to GCUA vehicles must be reported, via the Vehicle Accident Report, available in the glove

compartment of the car, to the GCUA Safety Coordinator and his/her supervisor by the end of the next working day.

Only authorized persons may be transported in GCUA vehicles.

GCUA vehicles shall be used for official, work-related activities only. This does not include such activities as excursions for check cashing, coffee break, or responding to an emergency non-work related.

Insurance premiums and registrations are paid by the GCUA. Current insurance and registration cards will be placed in vehicle glove compartments.

All occupants of GCUA vehicles must wear seat belts at all times.

Use of hand held cellphones while operating GCUA vehicles is strictly prohibited.

#### Employee(s) should:

Inspect the vehicle prior to operating it to ensure no problems are present and a safe trip is expected.

Ensure the current vehicle registration and insurance card are in his/her possession.

Ensure valid inspection sticker is displayed on windshield.

Obey the rules of the road and share the road courteously with others. If a parking or speeding ticket is issued; the employee is responsible for paying the fine. Furthermore, the employee must provide proof of such payment to his/her Department Head.

Keep vehicles assigned to him/her clean.

Fill out daily GCUA Vehicle usage sheets which are found in every vehicle.

Report any incidents involving GCUA vehicles which result in damages or injuries, no matter how minor, to his/her Supervisor <u>immediately</u>.

#### Department Head/designee should:

Ensure vehicles assigned to his/her department are clean, in good operating condition, serviced according to the established preventative maintenance schedule, and inspected by the New Jersey Division of Motor Vehicles as required.

Authorize employee(s) use of vehicles assigned to their work unit.

Provide proof of fine payments as applicable.

Ensure that an Accident Report is completed for any vehicle mishap.

Ensure the GCUA Safety Director is notified of county vehicle accidents involving a member of their staff in a timely fashion.
