RESOLUTION OF THE GLOUCESTER COUNTY UTILITIES AUTHORITY AUTHORIZING A CONTRACT WITH SCALFO ELECTRIC, INC. FOR COMBINED HEAT AND POWER ENGINES AS PART OF THE ANAEROBIC DIGESTER PROJECT

BACKGROUND

WHEREAS, Gloucester County Utilities Authority ("Authority") has constructed an anaerobic sludge digester with combined heat and power system at the Authority's Wastewater Treatment Plant located in West Deptford, New Jersey (collectively, the "Digester Project"); and

WHEREAS, the Digester Project requires the installation and operation of power engines ("Power Engines") to utilize the biogas produced by the Digester Project procured under separate contract; and

WHEREAS, N.J.S.A. 40A:11-5(gg), provides an exception to the public bidding requirement for wastewater treatment facilities as well as the construction of any part thereof as described below:

"40A:11-5 Exceptions. Any contract the amount of which exceeds the bid threshold, may be negotiated and awarded by the governing body without public advertising for bids and bidding therefor and shall be awarded by resolution of the governing body if:

(1) The subject matter thereof consists of:

(gg) A contract for the provision of water supply services or wastewater treatment services entered into pursuant to section 2 of P.L.2002, c.47 (C.40A:11-5.1), or the designing, financing, construction, operation, or maintenance, or any combination thereof, of a water supply facility as defined in subsection (16) of section 15 of P.L.1971, c.198 (C.40A:11-15) or a wastewater treatment system as defined in subsection (19) of section 15 of P.L.1971, c.198 (C.40A:11-15), or any component part or parts thereof, including a water filtration system as defined in subsection (16) of section 15 of P.L.1971, c.198 (C.40A:11-15)."

WHEREAS, the Authority has determined that the Power Engines are an integral part of the Digest Project and, therefore, the procurement process set forth above is applicable to any contract executed in connection therewith; and

WHEREAS, in furtherance thereof, the Authority sought pricing and quotes from four (4) separate contractors for the Power Engines, including Calvi Electric Company, DCO Energy, Scalfo Electric, Inc. and Thomas Controls, Inc.; and

WHEREAS, Scalfo Electric., Inc., provided a proposal price not to exceed \$6,936,000.00 (inclusive of base bid amount of \$6,859,000.00 and an alternate bid of \$77,000.00), which was deemed the most competitive price of the two (2) prices obtained;

NOW, THEREFORE, BE IT RESOLVED by the Gloucester County Utilities Authority and the members thereof, that the contract proposal provided by Scalfo Electric, Inc. ("Scalfo") for purpose of providing and installing the Power Engines as part of the Digester Project is hereby authorized and approved; and

BE IT FURTHER RESOLOVED, that the Chairman, Vice Chairman, Executive Director, Deputy Executive Director (or other duly authorized representative of the Authority) are hereby authorized and directed to enter into a contract with Scalfo with such changes as the Authority, together with its professional advisors and counsel, deem necessary or advisable; and

BE IT FURTHER RESOLVED, that the contract referred to in the immediately preceding paragraph is contingent upon the following:

- (i) the Authority's receipt of funding for the Power Engines from the Environmental Infrastructure Trust or the certification of availability of funds of Authority from its own funds and accounts or other sources;
- (ii) approval of the New Jersey Department of Environmental Protection; and
- (iii) submission of the contract to and/or obtainment of approval by (if required), the New Jersey Office of the State Comptroller, as applicable.
