WHEREAS, the GCUA Engineer has certified in an April 15, 2024, letter to the GCUA that the emergency purchase of two (2) 50 HP motors is necessary for compliance and safety to the public; an emergency contract was awarded in accordance with the procedures for emergency contracts as promulgated and contained in N.J.A.C. 5:34-6.1, et seq. and N.J.S.A. 40A:11-1, et seq.; and

WHEREAS, the GCUA Engineer has certified and confirmed that the emergency purchase is a one-time event to address the immediate need to ensure there are two spare motors on standby in case of a pump motor failure as there is a ten-week lead time for new motors; and

WHEREAS, the GCUA Engineer's April 15, 2024, written letter opinion certifying this as an emergency purchase and recommended payment for the emergency purchase to Willier Electric Motor Repair, Inc. based on the quote received of \$18,952.00 plus allowances for unforeseen items for a total amount not to exceed \$20,000.00, the Engineer's opinion is incorporated herein and made a part hereof this resolution.

WHEREAS, the Executive Director has certified that sufficient funds are available for the purpose of such a purchase and that funds have been appropriated for the budget year.
